A. DOG/PUPPY DESCRIPTION:

B. CONDITIONS OF SALE:

Under NO CIRCUMSTANCES is the dog to be used as a puppy mill. The Seller guarantees that the puppy is in good health on the date of delivery. The Buyer has the right to return the puppy to the Seller within three days after delivery and receive a refund of the purchase price if the puppy is found by a veterinarian to be suffering

C. HEALTH GUARANTEE:

The seller guarantees this dog to be of sound health and temperament at the time of this sale. However the purchaser agrees to take this dog to a licensed veterinarian of his choice within 48 hours for a physical examination. Should the dog be determined to be in ill health, the cause of which is clearly attributable to the seller, the dog may, upon written diagnosis from said veterinarian, and purchase price shall be refunded in full or be given a dog of equal value in exchange but the choice to be determined by the seller. Any veterinarian's diagnosis shall be subject to confirmation by a veterinarian chosen and paid for by the seller. Should the said veterinarian not concur with the diagnosis, the matter shall be presented to a third veterinarian mutually agreed upon by the seller and the purchaser

D. BREEDING

The puppy or dog shall not be bred unless:

- It has been x-rayed and certified clear of hip dysplasia by a competent individual or organization,
- Has been certified clear of hereditary eye disease by a canine ophthalmologist
- Has displayed good herding ability
- Its breeding mate meets the conditions listed in 1-3 above

E. TRANSFER TO A THIRD PARTY

- If at any time in its life the puppy is to be sold or given away, the Buyer shall so notify the Seller and give the Seller first option to buy the puppy back at a mutually agreed price
- The Seller shall not sell the puppy, or its offspring (if any), to any individual or establishment in the business of buying and selling puppies for a profit.

F. REGISTRATION & PAPERS

The following are some of the papers that may be provided by the buyer to the seller:

- ▶ EAKC/SABT: Registration certificate (if applicable)
- ▶ Copy of Pedigree Certificate
- ▶ Vaccination/Medical certificates

The buyer of a dog/puppy should obtain all the dog's papers listed above at the same time the dog is purchased. If a dog is delivered or sold with the understanding that the papers will not be furnished, the buyer should sign a statement agreeing to this condition. This agreement should be kept in the seller's records. If the papers have been kept for payment of an additional amount of money, the buyer has, in effect, forfeited any rights to the papers. If at some later date the buyer wants papers, the EAKC/SABT can only advise the buyer to go back to the seller to resolve the matter.
